UNDER WHICH GOODS ARE ACCEPTED FOR SALE BY AUCTION

RESERVES : Unless a reserve is entered against an item on a fully completed and signed entry form all items will be considered to be without reserve and sold to the highest bidder.

LOTING : The Auctioneers reserve the right to lot, catalogue and display items in the manner they think fit. Entries must be confined to Saleable Items over the value of £200 and the Auctioneers reserve the right to refuse any item, even though catalogued if they consider them unsaleable. Any item sold must be in a suitable condition to perform the function for which it was constructed and all items will be sold as such unless stated to the contrary.

AGENCY : The Auctioneers act as Agents only and are not responsible for any default by the buyer. They disclaim liability for paying the Vendor until they have received settlement from the purchaser.

COMMISSION : 10% from £200 up to £999.00, 7.5% from £1000.00 to £2500, 5% over £2500 per item plus VAT. The commission is inclusive of all organising and advertising costs. There is a minimum commission of £5.00 per lot plus VAT whether sold or unsold.

ELECTRICAL GOODS : All electrical items must be accompanied by an Electrician Certificate stating the condition of the item. Any item without such a certificate will have the plugs and cables removed and be sold as scrap. The Auctioneers will then sell all electrical items as with any other items "without warranty" and any recourse regarding electrical items will be to the electrician providing the certificate. If items appear without a certificate the Auctioneers may obtain their own certificate and will account to the Vendor accordingly for all costs.
