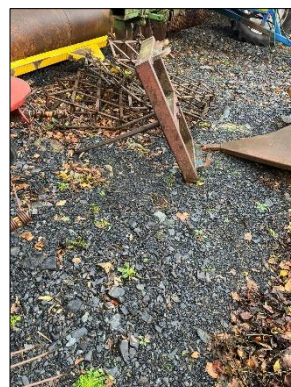

Purchaser Terms and Conditions

Registration

All purchasers must register and collect a Buyers Number before bidding. Photographic ID eg Passport or Drivers Licence and proof of address such as a Utility Bill will be required. Buyers Registration Form available at end of Terms & Conditions or can be downloaded from our website www.sunderlands.co.uk/livestock/machinery-and-dispersal-sales.

Payment

All items purchased must be paid for on the day of the sale immediately at the conclusion of the auction or earlier. Items must not be removed from the site until payment has been made to the satisfaction of the auctioneers. Please ensure that you have made arrangements for payment, satisfactory to the auctioneers before you attend the sale.

Payments on the day of the sale can be made by Cheque or cash payments up to £10,000 including VAT with identification can be accepted. Debit Card Payment Facilities are available.

Purchasers unknown to the Auctioneers may use a "Bankers Cheque" for the amount they wish to spend, "BACS" funds into our account, which usually takes 3 days, and remove the equipment after funds have cleared, make an immediate "CHAPS" payment directly into our account or a direct "Faster Payment" by internet into our account. If paying by "BACS", "CHAPS" or "Faster Payment": Please send funds to Lloyds Bank, Account No. 00296601 Sort Code 30 94 14.

Any Purchasers unknown to the Auctioneers without a "Bankers Cheque" or using "BACS" will have to wait for their cheques or payments to clear before removing the equipment.

Finance

If you are considering financing the equipment please make certain that the finance company are content to deal with auctioneers as we do not carry the same status with finance companies as machinery dealers or traders.

Buyers Premium

For Purchases in the field 5% Buyers Premium will be charged on the purchase price with a maximum of £1000 per lot and a minimum of £2 per lot unless otherwise stated and for Online Purchases 6.5% Buyers Premium will be charged on the purchase price with a maximum of £1000 per lot and a minimum of £2 per lot unless otherwise stated,

VAT

VAT will be charged on all lots at the standard rate of 20%.

All purchasers, whether based in the United Kingdom or internationally, are required to pay Value Added Tax (VAT) on all items subject to VAT before the goods are collected.

Non-UK Purchasers

Non-UK purchasers must supply Sunderlands 1862 LLP with their VAT/FISCAL number. They must pay the purchase price in full on the sale day plus the VAT on VAT-qualifying purchases.

For Non-UK purchasers exporting items outside of the United Kingdom, the VAT will only be refunded under the following conditions:

1. The purchaser must provide Sunderlands 1862 LLP with a valid Bill of Lading or Certificate of Shipment issued by the shipping or transport company as proof of export for HM Customs & Excise. This documentation must be submitted within 3 months of payment, clearly state the date, place, and vessel involved in the shipment and be an original document; photocopies will not be accepted unless officially authenticated by HM Customs & Excise
2. Before any VAT refund can be processed, the required documentation must be submitted in full and deemed satisfactory by Sunderlands 1862 LLP.
3. Sunderlands 1862 LLP reserves the right to withhold the VAT refund until all necessary export verification documents have been received and verified.

If the purchaser fails to provide the required documentation, Sunderlands 1862 LLP will retain VAT, and no refund will be issued.

This condition will be strictly adhered to without exception

NB. All overseas purchasers should contact the auctioneers at least two days prior to the sale to register and confirm their VAT status.
